# Can the gas storage cabinet be opened for ventilation



## Overview

---

While cabinet manufacturers may provide the bungs for venting, ventilation for flammable storage cabinets is NOT required or recommended by the National Fire Protection Association (NFPA) or the California Fire Code (CFC). When determining whether or not you should ventilate your safety cabinet, there are two primary reasons that the answer would be yes. First is that you are required by local legislation. Second is it will improve the work environment for employees in the workplace. Doors and access ports for exchanging cylinders and accessing pressure-regulating controls are allowed to be included. Chemical storage cabinets, whether used for flammables, corrosives or pesticides/poisons, come with capped bung openings that allow for ventilation.
