The Kingdom of Saudi Arabia (KSA) Minister of Finance has issued Ministerial Decree No. 1-88-1446, dated 01/05/1446 AH (corresponding to 11 July 2024), increasing the customs duty rates on specific electrical equipment and apparatus from 5% to 15%, effective from 16 July 2024. Currently, the applicable VAT rates in KSA are mainly categorized into three categories. Standard-rated supplies: Most. ET is charged at 100% on tobacco products, electronic smoking devices and energy drinks and at 50% on soft drinks. Are there any confirmed or anticipated changes to these rates?

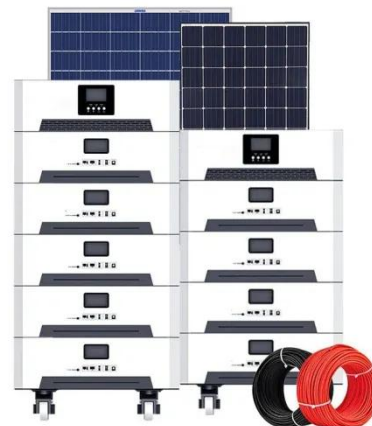


## Saudi Arabia VAT Guide for Cross-Border Sellers

## Indirect tax

Standard rate of 15% for most goods and services effective from 1st July 2020. (At the beginning of the VAT implementation in 2018, the VAT rate was 5%.)



## Taxable supplies of goods and services

Taxable supplies include both: Standard-

rated supplies, subject to VAT at the rate of 15 percent. Zero-rated supplies, which are taxable but subject to VAT at a rate of zero percent.



## VAT Guideline

A supplier must issue a tax invoice for each taxable supply made to any VAT-registered person or to any other legal person not subject to VAT, by no later than fifteen days following the end of the month in ...



## VAT rates of goods and services

Zero-rated goods and services are legally taxable but are taxed at a VAT rate of 0%.
