# Netherlands electricity regulations

The new act will enter into force on 1 January 2026. What will all this mean?

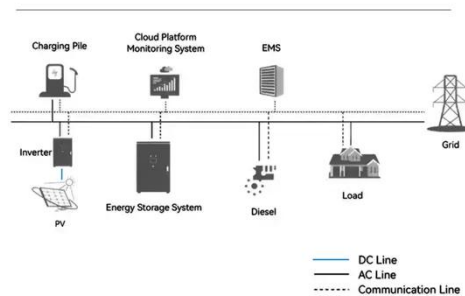
