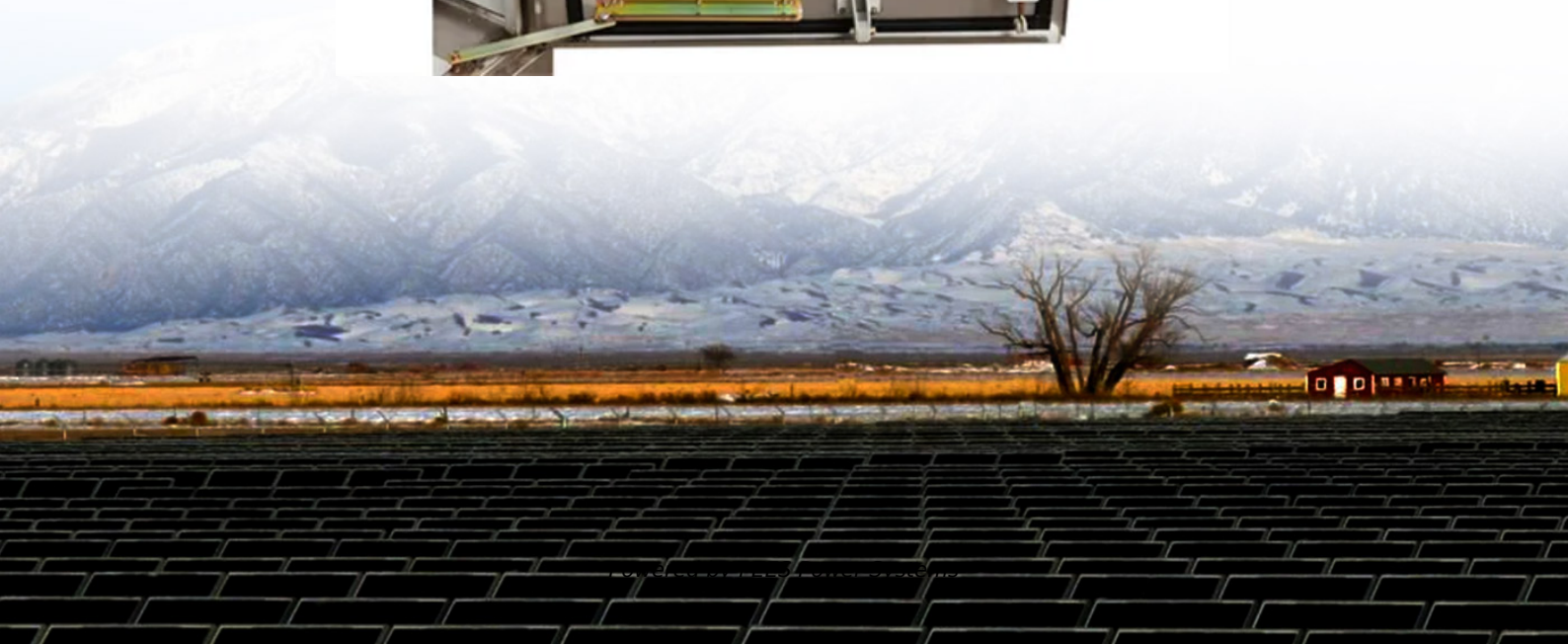

The Residential Clean Energy Credit equals 30% of the costs of new, qualified clean energy property for your. Beyond the federal 30% tax credit, state and local incentives can reduce your total solar costs by an additional 15-40%. Some states offer such generous programs that your net solar cost drops below \$10,000 for a typical home system. Any system installed after this year won't qualify for the discount that's helped millions of households cut thousands off their installation costs. 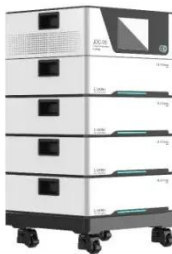

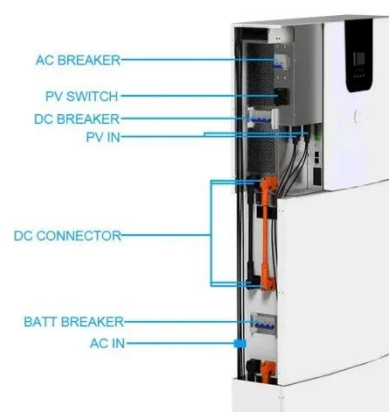
