Sweden announces subsidies for energy storage projects



Overview

It has announced a government subsidy that will cover 60% of the cost of installing a residential energy storage system up to a maximum of 50,000 kroner or \$5,600. The credit applies to the battery, wiring, control systems, smart energy hub, and installation work for homes with. The European Commission has approved, under EU State aid rules, a €3 billion (SEK 36 billion) Swedish scheme to support carbon capture and storage ('CCS') aimed at reducing carbon dioxide ('CO₂') released during the combustion or processing of biomass ('biogenic CO₂'). Competitive bidding to award grants for capturing at least 50,000 tonnes/year. Boosts Sweden's climate targets and EU's 2050 climate neutrality goal.
